# 1. INTRODUCTION

# 1.1 Purpose

This document specifies the Lloyds' Outward Reinsurance Scheme message (LLDUWR) that is sent between LORS participants. Its purpose is to advise the action taken by the authorising Underwriters in respect of specific ORI items.

# 1.2 References

The following documents have been used in the composition of this message:

- UN/EDIFACT Syntax rules (ISO 9735).
- UN Trade Data Elements Directory (ex ISO 7372).
- UN/EDIFACT Data Segments Directory.
- UN/EDIFACT Code Set Directory.

# 1.3 Field of Application

This message has been specifically designed for use within the Lloyds' Outward Reinsurance Scheme (LORS).

#### 1.4 Functional Definition

Currently there are two defined LORS business applications for LLDUWR. This document defines the structure and content of the data message which satisfies the following functionality.

#### 1.4.1 UNDERWRITER TO DXC

LLDUWR is used by Underwriters, who are participating in the scheme, to advise DXC of their action on an ORI item which they are required to authorise.

Underwriters can authorise or object to movements on ORI items (e.g. additions, amendments, cancellations, etc..), they can also change certain codes and references using the LLDUWR message. DXC validates the details and returns an Error and Confirmation message (LIMRES) for each LLDUWR received.

Some business items input by LPSO (Commutations & Terrorist Pool items) do not require authorisation and will be advised on a LIMRIA with a MOVEMENT TYPE of 'Authorised'. Underwriters can also use the LORS interactive system to authorise or object to ORI items submitted by the Brokers.



#### 1.4.2 DXC TO BROKER

LLDUWR is used by DXC to advise Brokers, who are participating in the LORS batch data message scheme, of an Underwriter's response to an ORI movement submitted by the Broker. The Underwriter's response may have been made via the LORS interactive system or via the LLDUWR message.

Brokers can also view Underwriter responses using the LORS interactive system.



# 2. MESSAGE DEFINIATION

#### 2.1 Introduction

The definition of an EDIFACT message that will satisfy a practical business application requires the unambiguous statement of:

- group and segment usage in the business context, which is defined in this appendix.
- the information hierarchy (the message structure), which is also defined in this appendix)
- the standard EDIFACT structures used to compose the message (refer to the LORS Batch Segment Directory in Appendix C).
- the code sets that will be used in the operational application (refer to the LORS Batch Code Set List in Appendix B).

# 2.2 Group and Segment Usage

#### 2.2.1 PURPOSE

Most of the segments used in this message were designed to be applicable over a wide range of messages covering various commercial and administrative applications. This section is provided to give details of their particular use within the LORS Underwriter Response Message.

#### 2.2.2 **USAGE**

#### UNB, Interchange Header

A mandatory service segment starting, identifying and specifying a transmission. The Application Reference for the LORS Underwriter Response Message is LIMORI.

#### UNH, Message Header

A mandatory service segment starting and uniquely identifying a message. The message type for the Underwriter Response Message is 'LLDUWR'.

#### NAD, Name and Address

A mandatory segment identifying the Broker.

#### RFF, References

A mandatory repeating segment providing the references required to uniquely identify the credit/debit item to which the response attaches.

#### GIS, General Indicator Segment

A mandatory segment indicating the movement that the response relates to.



# Segment Group 1.

#### **SEGMENT GROUP 1**

A mandatory repeating group of segments containing the Underwriter response to the credit/debit item. If the Underwriter acts on behalf of more than one Syndicate, for which there is a line, this group can repeat.

#### NAD, Name and Address

A mandatory segment identifying the client company/syndicate on the assured line.

#### GIS, General Indicator Segment

A mandatory repeating segment indicating the type of response made by the Underwriter and, if appropriate, the type of objection. The values of any codes updated on behalf of the Syndicate will also be given.

#### CTA, Contacts

A conditional segment providing Company/Syndicate contact information.

#### RFF, References

A conditional repeating segment indicating the line number of the assured line. Syndicate references that have been added/amended by the Underwriter will also be given.

#### DTM. Date and Time

A repeating conditional segment advising the Broker of the date and time that the response was received by the Bureau. If the accounting year has been changed on behalf of the Syndicate, it will also be advised.

#### FTX, Free Text

A repeating conditional text segment providing the reason for objection and any additional information supplied by the Underwriter.

# UNT, Message Trailer

A mandatory service segment sent to end and check the completeness of a message.

#### UNZ, Interchange Trailer

A mandatory service segment sent to end and check the completeness of an interchange.

The DTM segment is a London Market standard.


