1 Introduction

1.1 Purpose

This appendix specifies the Lloyds Outward Reinsurance Scheme message (LIMRIN) that is sent by Brokers, who are LORS EDI participants, to advise DXC of new and corrected Outward Reinsurance (ORI) business.

1.2 References

The bureaux involved in the design of this message were the Corporation of Lloyd's, the Institute of London Underwriters (ILU) and London Insurance and Reinsurance Market Association (LIRMA). The following documents have been used in the composition of this message:

- UN/EDIFACT Syntax rules (ISO 9735)
- UN Trade Data Elements Directory (ex ISO 7372)
- UN/EDIFACT Data Segments Directory
- UN/EDIFACT Code Set Directory

1.3 Field of Application

This message has been specifically designed for use within the Lloyd's Outward Reinsurance Scheme (LORS).

1.4 Functional Definition

Currently the only defined LORS business application for LIMRIN is to enable Brokers, who are participating in the scheme, to advise the DXC of new, amended or replacement ORI items.

When DXC receives a message, it validates the data and, if correct, makes the items available to the Underwriters who are responsible for authorising them prior to settlement. The Underwriters are advised of the items either via the LORS interactive system or via an Electronic Data Interchange (EDI) message.



This document defines the structure and content of the EDI message that satisfies the above functionality.

2 MESSAGE DESIGN

The Underwriter Response Message does not require the use of sections.

3 MESSAGE DEFINITION

3.1 Introduction

The definition of an EDIFACT message that will satisfy a practical business application requires the unambiguous statement of :

- group and segment usage in the business context, which is defined in this document.
- the information hierarchy (the message structure), which is also defined in this document.
- the standard EDIFACT structures used to compose the message (refer to the LORS Batch Segment Directory in Appendix C)
- the code sets that will be used in the operational application (refer to the LORS Batch Code Set List in Appendix B)

3.2 Group and Segment Usage

3.2.1 PURPOSE

Most of the segments used in this message were designed to be applicable over a wide range of messages covering various commercial and administrative applications. This section is provided to give details of their particular use within this message.



3.2.2 USAGE

UNB, Interchange Header

A mandatory service segment starting, identifying, and specifying a transmission. The Application Reference for the LORS New Business Message is LIMORI.

UNH, Message Header

A mandatory service segment starting and uniquely identifying a message. The message type for the LORS New Business Message is 'LIMRIN'.

GIS, General Indicator Segment

A mandatory segment indicating the type of transaction contained within the message.

NAD, Name and Address

A mandatory segment identifying the Broker.

CTA, Contacts

A mandatory repeating segment providing the name and telephone number of the person in the Broker office to whom queries, concerning the Credit/Debit item, can be directed.

RFF, **References**

A mandatory repeating segment providing the unique group reference that the Broker has allocated to a new group of associated credit/debit items. The Unique Market Reference that the Broker has allocated to the policy is also provided for, together with the reinsurance policy and original bureau signing reference.

CNT, Control Totals

A conditional segment that provides a count of the number of items contained within a group.

GIS, General Indicator Segment

A conditional segment which identifies the assigned Department of Trade and Industry audit code and whether the item(s) are for information only.

PCD, Percentage Details

A conditional segment that is repeated to give the details of any discount percentages that have been used to calculate the transaction amounts of the credit/debit items plus, when applicable, the percentage of the reinsuring company/syndicates that have been approved by the Department of Trade and Industry and the percentage of the reinsurance that has been ceded to Lloyd's.

DTM, Date and Time

A repeating conditional segment giving the dates when the reinsurance policy cover incepts and ends.

NAD, Name and Address

A conditional segment identifying the party/parties covered by the original policy/policies.

FTX, Free Text

A repeating conditional segment specifying additional information, concerning the reinsurance policy, in a textual format.

SEGMENT GROUP 1

A mandatory group of repeating segments which has other repeating groups nested within it. It contains instructions regarding the method and currency of settlement for the credit/debit items.

CUX, Currencies

A mandatory segment giving the settlement currency code.

GIS, General Indicator Segment

A repeating conditional segment providing details of the preferred settlement method.

RFF, References

A mandatory segment giving the unique reference that the Broker has allocated to the settlement currency split of a premium or claim transaction.

DTM, Date and Time

A conditional segment that is present if the Broker wishes to specify the date on which settlement should take place.

FTX, Free Text

A repeating conditional segment providing additional details concerning the settlement or any other information that can be applied to all of the items that are covered by the specified Transaction Reference, e.g. the reason why a member of the reinsuring market has not fully paid an outstanding claim. Segment Group 2.

SEGMENT GROUP 2

A mandatory group of repeating segments which has other repeating groups nested within it. It contains details relating to the individual credit/debit items.



PCD, Percentage Details

A mandatory segment providing the total percentage of the contract policy that has been reinsured. This equates

to the total of the client Company/Syndicate lines.

SEGMENT GROUP 3

RFF, References

A mandatory repeating segment giving the unique Lloyd's Item Number and the nonunique Credit/Debit Note Number (Broker Reference 2) that have been allocated by the Broker to a credit/debit item, plus the Bureau Signing Reference allocated by Lloyd's when an item is sent for settlement.

DTM, Date and Time

A conditional segment giving the accounting year into which the credit/debit item is to be paid.

MOA, Monetary Amount

A conditional repeating segment providing the monetary amount details of the credit/debit item.

SEGMENT GROUP 4.

GIS, General Indicator Segment

A mandatory repeating segment providing the various processing indicators to be applied by Lloyd's.

PCD, Percentages

A conditional repeating segment providing the percentages used to calculate the total Credit/Debit amounts.

FTX, Free Text

A repeating conditional segment providing additional details relating to the individual credit/debit item.

Segment Group 5.

Segment Group 6.

SEGMENT GROUP 3

A conditional group of repeating segments, nested within Segment Group 2, that provides information regarding the reinsuring company market.

It is a **mandatory** Group for all USD Premium Debit and Credit business.



NAD, Name and Address

A segment that is mandatory within this conditional segment group. It gives the code, and where applicable the

name, of members of the company reinsuring market.

RFF, References

A conditional segment providing the reference of the collection note within which the reinsurer amount was

originally included.

GIS, General Indicator Segment

A repeating segment that is mandatory within this conditional segment group. It is used to indicate the payment

status and role of the company/syndicate identified in the preceding NAD segment.

MOA, Monetary Amount

A conditional segment giving the amount that the party, identified in the NAD segment, has paid or has yet to

pay.

SEGMENT GROUP 4

A conditional group of repeating segments that is nested within Segment Group 2. It will be present if the Broker

has any claims and loss details to advise.

NAD, Name and Address

A segment that is mandatory within this conditional segment group. It provides the name of the loss that has resulted in the claim.

RFF, References

This repeating segment is conditional within the segment group. It provides the claims reference and the

catastrophe reference code that has been allocated by the claim's office.

DTM, Date and Time

A conditional repeating segment giving the period in which the loss occurred.

FTX, Free Text

A conditional segment providing narrative details relating to the loss.

SEGMENT GROUP 5

A mandatory group of repeating segments that is nested within Segment Group 2. It contains the client

company/syndicate details.

NAD, Name and Address

A mandatory segment identifying the client company/syndicate.

RFF, References

A mandatory repeating segment providing the line number and, if known, the Underwriter's references.

PCD, Percentage Details

A mandatory segment containing the percentage of the total credit/debit amount that the client

company/syndicate will pay/receive.

MOA, Monetary Amount

A mandatory segment containing the amount that the client company/syndicate will pay/receive in respect of the pradit/debit item

credit/debit item.

SEGMENT GROUP 6

A conditional group of repeating segments which is nested within Segment Group 2. It contains the instalment

details if credit/debit item is a deferred payment.

RFF, References

This segment is mandatory within this segment group. It contains the unique instalment number.

DTM, Date and Time

This segment is mandatory within this segment group. It contains the date that the instalment is due to be settled.

MOA, Monetary Amount

This segment is mandatory within this segment group. It contains the monetary amount of a deferred payment.

UNT, Message Trailer

A mandatory service segment sent to end and check the completeness of a message.

UNZ, Interchange Trailer

A mandatory service segment sent to end and check the completeness of an interchange.

The GIS segment is drawn from the UN/EDIFACT Quality Control segment directory dated June 1990.


The PCD and DTM segments are London specific standards.
